

GENERAL TERMS & CONDITIONS, WAIVER & RELEASE FORM

- 1. I understand that part of the camp experience involves activities, group living arrangements and interactions that may be new to the camper. I understand that they come with certain risks and uncertainties beyond what the camper may be used to dealing with at home. I am aware of these risks, and I am assuming them on behalf of the camper. I realize that no environment is risk-free, and so I have instructed the camper on the importance of abiding by Grotonwood's rules. The camper understands that Grotonwood reserves the right to dismiss any camper from further participation in the program in the event the program staff determine that they cannot meet the program eligibility requirements. Supervision and transportation resulting from dismissal are the responsibility of the family/guardian. If a camper is sent home for behavioral reasons, NO refund will be given.
- 2. Deposits are non refundable and non transferable COVID-19 related medical reasons are the exception. Fees for campers leaving before the end of their session are given on a pro-rated basis, and ONLY if a camper must leave early for medical reasons. Additionally, refunds for cancellations prior to the session start date will only be given for medical reasons. In both cases, evidence in the form of a physician or hospital note must be provided.
- 3. Lost Property: Guardian understands that Grotonwood and its representatives are not responsible for loss or damage to personal property and possessions of the camper. This includes cell phones, and other electronic devices. The guardian is liable for any damage to the property of Grotonwood resulting from the acts of the camper.
- 4. Photograph/Video Consent: Guardian consents to the use of any film/photographs/video taken during the program, whether for advertising, promotion, and/or publicity purposes by Grotonwood unless otherwise indicated in writing prior to the program. The camper waives all claims of compensation for such use.
- 5. Permission is granted for camper to attend program field trips. An itinerary will be available at check-In.
- 6. Parents and Legal Guardians may request copies of staff and volunteer background checks, health care and discipline policies, as well as procedures for filing grievances by contacting the camp office at the address below.
- 7. All campers will be required to follow preventive measures as outlined by the Center for Disease Control (CDC), This includes regular hand washing and wearing a face mask at all times whenever physical distancing is not possible. Exceptions are meal time, swim time and for medical reasons. When onsite, Parents and caregivers should also wear a mask during check-in/check-out and remain in vehicle unless asked otherwise by camp staff.

COVID-19 WARNING & DISCLAIMER

Coronavirus (COVID-19), is an extremely contagious virus that spreads easily through person-to person contact. Federal and state authorities recommend physical distancing as a mean to prevent the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Attending camp could increase the risk of contracting COVID-19. Grotonwood in no way warrants that COVID-19 infection will not occur through participation of Grotonwood programs. If an outbreak of COVID-19 occurs at camp during your campers session, you must be prepared to collect your camper(s) at very short notice.

In consideration of the camper named below, as parent/legal guardian, on behalf of myself, my heirs, representatives, executors, administrators, and assigns, HEREBY do release Grotonwood, its officers, directors, employees, volunteers, agents, representatives and insurers ("Releasees") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Grotonwood on account of personal injury, property damage, death or accident of any kind arising out of or in the participation in Grotonwood programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of releasees.

I agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of, or in any way related to the camper named on page one of this form attendance at Grotonwood. I hereby certify that I have full knowledge of the nature and extent of the risks inherent in attending camp and that I am voluntarily assuming said risks.

I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, sustained while participating in camp and that by signing this agreement I HEREBY RELEASE Releasees from all liability for such loss, damage, or death.
